

## NEW JERSEY LAW EXAMINATION INFORMATION SHEET

The New Jersey Law Examination is an examination that all candidates must pass prior to receiving a certificate or being licensed in New Jersey. The examination content is taken from the *New Jersey Statutes, Rules and Regulations*, which have previously been provided to candidates by the New Jersey Board. If you do not have a copy of the *New Jersey Statutes, Rules, and Regulations* booklet, please contact the New Jersey Board at 973-504-6460. PCS does not provide this booklet.

Please record your **Name** and **10-digit NCEES exam identification number** on the front cover of the examination booklet and the PCS answer sheet, leave the **Exam Date** area of the PCS answer sheet blank; also color in the bubbles for each digit or letter put on the answer sheet. Carefully review the front cover of the examination booklet. The information contained on this sheet is very important and may affect your final grade if you fail to properly complete the answer sheet. If you do not know your 10-digit exam identification number, you may obtain it by logging into your account at [www.ncees.org](http://www.ncees.org).

The examination booklet and *unfolded* answer sheet must be returned to Professional Credential Services. For your convenience, a pre-addressed envelope has been provided. **Folded answer sheets will not be scanned and therefore will not be scored.** Please see reverse side for return instructions.

Your Law Examination score will be reported to you around the time the Fundamentals and Principles and Practice of Engineering and Land Surveying results are available on line at NCEES or shortly thereafter. Typically, scores are available in January for the fall examination and July for the spring examination. You are required to correctly answer 70% or 14 of the 20 questions in order to pass the examination.

Examination booklets and answer sheets received after the return deadline will **NOT** be scored. To re-take this examination in the future you must go to a testing site (the privilege of testing by mail has been lost) if you have already been successful on the National examination. Future Law examinees must either:

Contact PCS to schedule the Law Examination if you must take a national examination again. You must mail the original examination booklet assigned to you, or a signed affidavit stating that you no longer know the whereabouts of the examination booklet.

OR

Contact the New Jersey State Board of Professional Engineers and Land Surveyors (if you have already been successful at the national examination) to schedule the Law Examination at the Board offices in Newark, New Jersey. You must bring to the testing site the original examination booklet assigned to you, or a signed affidavit stating that you no longer know the whereabouts of the examination booklet.
