- Virginia licensed cosmetologist with two years of work experience
Required Documentation: A completed *Training & Experience Verification Form*
- Virginia licensed cosmetologist or cosmetology student (with less than two years of work experience) enrolled in a Virginia barber training school and seeking credit for performances completed at a cosmetology school
Required Documentation: A completed *Training & Experience Verification Form*
- Barber training obtained in any Virginia state institution
Required Documentation: A completed *Training & Experience Verification Form*
- Two years of barbering experience in the United States armed forces
